Due to recent legislation changes, it is important that we seek permission from yourself and your child (over the age of 13) to take and use these images for these stated purposes. Please could you discuss with your child whether they are happy to give ChristChurch Redbourn permission to include them in any photographs or videos taken and complete the consent box below as appropriate.

Conditions of Use

1. We will not include details or full names (which means first name and surname) of any person in an image on our website or in printed publication without good reason and only with your express consent.
2. We will not include personal e-mail or postal addresses or telephone numbers on our website or in printed publications.
3. We may use group images with very general labels such as “youth enjoying sport” or “making Christmas decorations”.
4. We will only use images of children/young people who are suitably dressed to reduce the risk of such images being used inappropriately.

CODE OF CONDUCT

We think that our young people know what sort of behaviour is expected of them, so we haven't written an official set of rules for them. If they're really unsure, perhaps the Illuminate Code of Conduct can give them some guidance:

1. Caring Hands (We should not be hurting anyone else; or messing around with something when we should be listening, or treating other property in the wrong way)

2. Caring Mouths (We speak kindly and at the right time; not over the top of the leaders)

3. Caring Ears (We listen when someone else is talking, especially a leader)

DISCIPLINE

Yellow Card - this means they were put in time out after not responding to verbal warnings. We will speak to you if your young person was given a yellow card.

Red Card - after a yellow card, if they do not change their behaviour, they may be given a red card. We will speak to you if this is the case, and they will be asked to miss the next session of Fish Tank.
